

### **TERMS AND CONDITIONS**

#### **BACKGROUND:**

These Terms and Conditions, together with any and all other documents referred to herein, set out the terms of use under which you may use this website, <a href="https://www.plugandcharge.co.uk">www.plugandcharge.co.uk</a> ("Our Site"). Please read these Terms and Conditions carefully and ensure that you understand them. Your agreement to comply with and be bound by these Terms and Conditions is deemed to occur upon your first use of Our Site. If you do not agree to comply with and be bound by these Terms and Conditions, you must stop using Our Site immediately.

## 1. Definitions and Interpretation

1. In these Terms and Conditions, unless the context otherwise requires, the following expressions have the following meanings:

# 2. Information About Us

- 2. We are regulated by the NICEIC.
- 3. We are a member of Trustatrader.com, Constructionline, Which Trusted trader and Surrey Trading Standards Approved.

## 3. Access to Our Site

- 1. Access to Our Site is free of charge.
- 2. It is your responsibility to make any and all arrangements necessary in order to access Our Site.
